IF THE CAR IS ALREADY BUILT AND YOU ARE APPLYING FOR A NEW RALLY PERMIT OR RE-ISSUE, you must submit the car for a determination of ELIGIBILITY BEFORE seeking inspection. [PLEASE COMPLETE FORMS ON PAGES 16, 17, 18 & 19.](#)

ONCE ELIGIBILITY IS DETERMINED, your next step will be an inspection by an RP Scheme Authorised Vehicle Inspector. I will advise you of the contact details for the Authorised Inspectors once Eligibility has been determined.

PLEASE NOTE, THERE ARE ONLY SPECIFIC INSPECTORS AUTHORISED TO CONDUCT INSPECTIONS FOR THE RP SCHEME. Other CAMS Scrutineers are NOT authorised for this work.

If your vehicle has passed Eligibility and Inspection, we issue VicRoads with a "Request to issue RP Plates."

Present this "Request" and the inspection documents at VicRoads KEW office – please note, no other offices can issue RP plates - sign the Vehicle Owners Agreement, pay the fees receive your Rally Permit.

Thank you for your enquiry about renewal of your Victorian Rally Permit.

Please see attached.

The steps to Renewal of your RP plates are:

1. Determination of Renewal Eligibility
2. Vehicle Inspection by an Authorised RP Scheme Vehicle Inspector if requested by the Eligibility Committee.
3. Renewal of RP plates by VicRoads Kew Office.

IF YOU ARE APPLYING FOR RE-ISSUE OF A RALLY PERMIT, you must submit the car for a determination of ELIGIBILITY for RENEWAL, An inspection may be required at the request of the Eligibility Committee.

- **PLEASE COMPLETE FORMS ON PAGE 17 (Application & Assessment – Vehicle Eligibility for Victorian Rally Permit)**

And

- **Include a copy of your CAMS Logbook identifying events competed in under the Permit during the previous 12 months.**

Note:

- **If vehicle had a change of ownership a new application must be made as RP Permits are non-transferable.**
- **If vehicle has been modified or had significant damage repaired then an inspection will be requested at the Eligibility Committees discretion.**

ONCE ELIGIBILITY FOR RENEWAL IS DETERMINED

If your vehicle has passed Eligibility and Inspection (if required), we issue VicRoads with a "Request to issue RP Plates."

Present this 'Request' and the renewal documents at VicRoads KEW office – please note, no other offices can issue RP plates - sign the Vehicle Owners Agreement, pay the fees receive your Rally Permit Renewal.
